

DOG PURCHASE AGREEMENT

This Dog Purchase Agreement ("Agreement") is entered into between **Mattie Henry ("Seller")** and the individual identified below as **Buyer**. This Agreement becomes effective on the date it is signed by both parties.

1. SELLER INFORMATION

3. PURCHASE PRICE & PAYMENT

The total purchase price of the dog is \$_____.

A **non-refundable deposit of \$250.00** has been paid and will be applied toward the total purchase price.

The remaining balance of \$_____ is due in full on or before the date of pickup or delivery, unless otherwise agreed upon in writing by both parties.

The deposit reserves the specific dog identified in this Agreement for the Buyer. Because the Seller may decline other potential buyers after a deposit has been received, the deposit is non-refundable if the Buyer chooses not to complete the purchase, except where otherwise required by applicable law.

4. HEALTH GUARANTEE

The Seller represents that, to the best of the Seller's knowledge, the dog is in good health at the time of sale.

The Buyer agrees to have the dog examined by a licensed veterinarian within **three (3) days** of taking possession of the dog.

If the veterinarian identifies a **serious health condition that may have existed prior to the transfer of the dog**, the Buyer agrees to notify the Seller as soon as reasonably possible and provide appropriate veterinary documentation.

The Seller's health guarantee is intended to address **serious or significant health conditions that were present or developing prior to the transfer of the dog**. The Seller does not provide reimbursement, refunds, replacement puppies, or financial assistance for **minor, common, or routine health concerns** that may occur after the dog goes home.

5. VACCINATIONS & CARE

The dog will receive age-appropriate vaccinations, deworming, and routine care while in the Seller's care.

Available veterinary and vaccination records will be provided to the Buyer at the time of sale.

After the dog is transferred to the Buyer, the Buyer assumes responsibility for all future veterinary care, vaccinations, preventative care, and medical expenses.

6. BUYER RESPONSIBILITIES

The Buyer agrees to:

- Provide the dog with proper food and fresh water.
- Provide safe and appropriate shelter.
- Provide regular and necessary veterinary care.
- Maintain appropriate vaccinations and preventative care.
- Treat the dog humanely and responsibly.
- Provide appropriate supervision, exercise, training, and socialization.
- Comply with all applicable local, state, and federal laws and regulations regarding pet ownership.

The Buyer understands that ownership of a dog is a long-term commitment and agrees to make reasonable efforts to provide the dog with appropriate care throughout its lifetime.

7. NON-REFUND POLICY

Except as otherwise specifically provided in this Agreement or required by applicable law, all sales are final once the dog has been transferred to the Buyer.

The Buyer understands that a change in circumstances, change of mind, or inability to keep the dog does not automatically entitle the Buyer to a refund.

8. RETURN & REHOMING POLICY

If the Buyer becomes unable or unwilling to keep the dog, the Buyer agrees to contact the Seller before rehoming, transferring, or surrendering the dog whenever reasonably possible.

The Seller would like the opportunity to assist with determining an appropriate solution for the dog, which may include assisting with rehoming or arranging for the dog to return to the Seller when reasonably possible.

Returning the dog to the Seller does not automatically entitle the Buyer to a refund unless otherwise agreed upon in writing or required by applicable law.

The Buyer agrees not to abandon the dog or knowingly place the dog in an unsafe or neglectful situation.

9. TRANSFER OF RESPONSIBILITY & LIABILITY

Once the dog has been physically transferred to the Buyer and the purchase price has been paid in full, the Buyer assumes responsibility for the dog's care, supervision, transportation, veterinary expenses, and other ordinary costs associated with ownership.

Except as otherwise provided in this Agreement or required by applicable law, the Seller shall not be responsible for damages, injuries, illnesses, veterinary expenses, or other costs arising after the dog has been transferred to the Buyer.

10. ENTIRE AGREEMENT

This Agreement represents the entire understanding between the Seller and Buyer regarding the purchase and transfer of the dog identified herein.

Any changes or additional agreements must be made in writing and agreed to by both parties.

If any provision of this Agreement is determined to be invalid or unenforceable, the remaining provisions shall remain in effect to the extent permitted by law.

This Agreement shall be governed by the laws of the **State of Illinois**, unless applicable law requires otherwise.

11. ACKNOWLEDGMENT & SIGNATURES

By signing below, both parties acknowledge that they have read and understand this Agreement and voluntarily agree to the terms contained herein.

The Buyer acknowledges that they have had the opportunity to ask questions regarding the dog, its health, care, and the terms of this purchase before signing.
